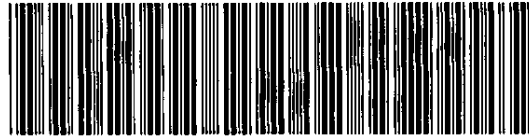

Amendment to Articles of Incorporation

Proposed Activities

The current artwork is entitled the "Lost Heroes Art Project" which is a memorial tribute to the fallen service men and women from the Iraq and Afghanistan wars. It is currently traveling across the United States to museums and State Capitol buildings. At the end of it's travel in 2011 it will be auctioned off to a collector or museum and all proceeds will be donated to two charities: CAUSE and TAPS. This artwork to recognize American Heroes was created by Julie Feingold, President of American Heroes Art Projects Foundation. Future artworks for the organization would also be created by Julie Feingold or other visual artists.

Nancy Hecker has edited a companion book for the project. This companion book is being sold on the website of the project (www.LostHeroesArtQuilt.org) and at specific venues where the artwork is being exhibited. All proceeds after expenses of printing the book will be donated to a charity called Snowball Express, which helps the young children of the fallen Heroes.

The 200 page companion book to the "Lost Heroes Art Quilt" project features stories and photos about the 82 fallen Heroes represented on the "Lost Heroes Art Quilt" plus a listing of all of the fallen from the Iraq and Afghanistan wars up until July of 2009.

Other donations are solicited on our website and by word of mouth to help fund the travel of the artwork across America. Transport of the artwork is done either by the artist and the families participating in the projects and/or by a freight company which is paid by the donations we have received.

All persons involved in the activities of the American Heroes Art Projects Foundation are un-paid volunteers, and are paid no charges or fees.

There are no financial or business transactions between officers, board members, or relatives of the American Heroes Art Projects Foundation.

Proceeds from the sale of the Quilt itself and its stand will go to two charities support the military families. CAUSE helps wounded warriors returning home to the U.S.A., TAPS is a tragedy assistance program for families of the fallen. The Quilt will be auctioned off at a charity event sponsored by CAUSE in November of 2011.

Julie Feingold and/or American Heroes Art Projects Foundation retains the copyrights for the companion books published and for the fine artwork design of the Lost Heroes Art Quilt.

Current and future activities in relation to The Lost Heroes Art Quilt will be on a volunteer basis with no payment given, except for transportation and insurance costs related to travel of the artwork whereby we will pay related costs through donations received.


