of

In Compliance with Chapter 617, F.S., (Not for Profit)

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

First: The name of the Corporation shall be Pasco Veterans Council, Inc.

Second: The place in this state where the principal office of the Corporation is to be located at 7330 Jenner Ave, New Port Richey, Florida in Pasco County. 34655

Third: The purpose of the Pasco Veterans Council, Inc. is to assist Veterans, members of the US Armed Forces and their families.

This organization shall engage in no activities, except to an insubstantial degree, that are not in furtherance of its purpose as set forth in Article 3 above.

Sixth: Upon the dissolution of the corporation, assets shall be distributed to a Pasco County veterans Organization for one or more exempt purposes within the meaning of section 501(c) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Seventh: Election of officers and board members shall be in accordance with the by-law.
