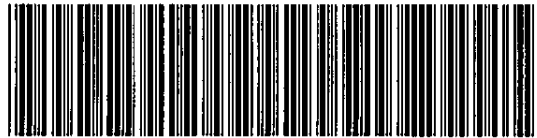

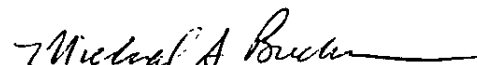

Article I Purpose

All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.
