ARTICLES OF INCORPORATION OF PARIS WHITEHEAD HAMILTON FOUNDATION OF ARTS, INC., A Florida not for Profit Corporation

ARTICLE I CORPORATE NAME

The name of the corporation is Paris Whitehead Hamilton Foundation of Arts, Inc.

ARTICLE II CORPORATE ADDRESS
