ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION SECRETARY OF STATE RALD COAST AUTISM CENTER, INC.,

a Florida Not-For-Profit Corporation

Pursuant to the provisions of Chapter 617, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation by the majority of the Board of Directors as there are no members entitled to vote on the amendments:

1. Article III is hereby amended and restated as follows:

Said organization is organized exclusively for charitable, religious, education and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

2. Article IX shall be added to the Articles of Incorporation as follows:

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

3. Article X shall be added to the Articles of Incorporation as follows:

The Emerald Coast Autism Center, Inc. admits students of any race, color, and national or ethnic origin to all the rights, privileges, programs and activities generally accorded or made available to students at our school and does not discriminate on the basis of race, color and national or ethnic origin in administration of our educational policies, admissions policies, scholarship and loan programs and athletic and other school-administered programs.

THE FOREGOING amendments were approved and adopted by a majority of the directors on November 16, 2009.
