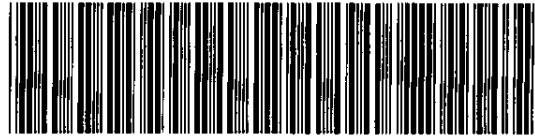



- b. Upon the dissolution of the Corporation, The Board of Directors shall assets shall, after paying or making provision for payment of all liabilities of the Corporation shall dispose of the residual assets by distribution to one or more exempt purpose within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Any such assets not disposed of shall be disposed of by the court of Competent Jurisdiction/ Superior Court of the county in which the principal office of the Corporation is located exclusively for such purpose or to such Corporation or Corporations, as said Court shall determine which are organized and operated exclusively for such purposes.*
