**ARTICLES OF INCORPORATION  
OF

The undersigned incorporator, being a citizen of the United States, desires to form a not for profit corporation under Chapter 617 of Title XXXVI of the Florida Statutes, and does hereby certify:

**Article One - Name**

The name of the corporation shall be "**Bloggers Retreat, Inc.**", and shall hereinafter be referred to as the "Bloggers Retreat".

**Article Two - Address**

The street address of the principal office of Bloggers Retreat shall be 4792 U.S. Highway 90, Unit X, Marianna, Florida 32446.

**Article Three - Purposes and Powers**

(A) Bloggers Retreat is organized exclusively for charitable purposes within the meaning of Section 501(c)(3) of the United States Internal Revenue Code of 1986, as amended (the "Code"), in providing a retreat event for Christian women devotional blog writers, speakers and women's organization leaders, as a non-denominational fellowship, as well as any other

projects for public benefit, and to advance such purposes by any activity in which a corporation organized as a not for profit corporation under the laws of Florida may engage.

(B) Bloggers Retreat shall be empowered to do and perform such acts as may be necessary or appropriate in carrying out the foregoing purposes of Bloggers Retreat and in connection therewith to exercise any of the powers granted to not for profit corporations by Fla. Stat. ch. 617.0302. Notwithstanding the foregoing, Bloggers Retreat shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501(c)(3) of the Code, or to which contributions are deductible under Section 170(c)(2) of the Code.

#### **Article Four - Initial Directors and Manner of Election**

The number of Directors constituting the initial Board of Directors is three (3), and thereafter, the Board of Directors shall consist of at least three (3) members, and not more than fifteen (15) members. The members of the initial Board of Directors shall hold office until the first meeting of the Board of Directors or until their successors shall have been elected and qualified in the manner stated in the ByLaws. The names and addresses of the persons who are to serve as the initial directors are:

#### **Article Five - Registered Agent and Street Address**

The location and mailing address of the initial registered office of Bloggers Retreat shall be 4792 U.S. Highway 90, Unit X, Marianna, Florida 32446, and the name of its initial registered agent at such address shall be **Angie Knight**.

#### **Article Six - Incorporator**

The name and address of the incorporator is **Joe M. Chambers**, P.O. Box 2246, Dothan, Alabama 36302.


#### **Article Seven - No Private Inurement**

No part of the net earnings of Bloggers Retreat shall inure to the benefit of or be distributable to its directors, officers or other private persons, except that Bloggers Retreat shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of Bloggers Retreat shall be the carrying on of propaganda or otherwise attempting to influence legislation, and Bloggers Retreat shall not participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office.

#### **Article Eight - Distributions Upon Dissolution**

In the event of dissolution of Bloggers Retreat for any reason, the remaining Bloggers Retreat assets shall (after payment or provision for payment of all liabilities) be distributed to an organization or organizations, which are organized and operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Code, or to one or more governmental units referred to in Section 170(c)(1) of the Code.


