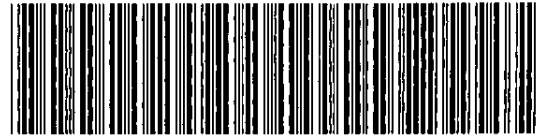

Please be advised that we are the independent accountants of Iglesia Rios de Agua Viva de New Port Richey, Inc. Document No. 9000005453.

Las August 3, 2012 our client filed Articles of Amendment changing several corporate officers and removing others as per a mandate of the assembly and by the unanimous vote of the flock, in which our firm was present by auditing the voting results.

On the same date, and with the intent of deceiving the members of the church and intentionally distorting the outcome of the elections, the former president and Pastor of the church, Carlos Castillo, who voluntarily resigned as President of the corporation a few months ago, amid accusations of the misappropriation of more than 25,000 of the church's funds in 2011, using the name of an individual with an alias of Othoniel L. Altidor, falsely, filed new articles of amendment appointing this last as Treasurer and Registered Agent of the entity.

The church is hereby refilling Articles of Amendment appointing Rosa A. Quiñones as registered agent and Hilaria Fuentes as Treasurer as per the church's mandate.

We, hereby, request on behalf of the Church (our client), not to accept and disregard any Articles of Amendment filed in a near future if they are not signed by the President of the corporation Mrs. Rosa A. Quiñones.

Meanwhile and considering the scope and reach of the fraudulent actions of Mr. Castillo and his helpers, it is our intention to initiate the corresponding legal action and to press the applicable criminal charges based on the evidence at hand.
