The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act hereby adopt(s) the following Articles of Incorporation:

Article III Purpose

The purpose for which the corporation is organized is:

The G.A.P. Program is designed to inform participants about gang life and how it affects them as individuals and the community as a whole. The intent is to rehabilitate youth that are involved in gang activity and redirect youth that are considering becoming involved in a gang. In an effort to aid in making participants an asset to their community this program will teach youth the importance of an education, how to value themselves, and life skills that are critical to their success.
