

2. Replace Article III - (The Specific Purpose for which this Corporation is Established)

To raise funds to support Youth Sailing Programs which allow disadvantaged children to learn the essential elements of seamanship, water safety, and participate in National and International amateur racing competitions and to support local charitable and educational organizations that qualify under Sec. 501(c) (3) of the Internal Revenue Code.

3. ADD Article VI (Dissolution Clause)

The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof to the benefit of any private person.
