## PLAN OF DISTRIBUTION OF ASSETS OF SYS CHARITABLE FOUNDATION, INC.

The directors upon unanimous decision and action, have determined that it is in the best interest of SYC Charitable Foundation, Inc. (SYCCF) that the corporation be wound up and dissolved and, thereby, terminate its existence. SYCCF has no members, and the officers and directors of the corporation are authorized and directed to take appropriate measures to wind up and dissolve the corporation.

The Board of Directors unanimously determined that SYCCF shall be dissolved in accordance with the articles of incorporation, the bylaws of the Corporation and the laws of State of Florida. SYCCF's articles of incorporation and bylaws require that upon dissolution, its assets remaining after payment, or provision for payment, of all debts and liabilities of SYCCF shall be distributed to a nonprofit fund, foundation, or corporation which is organized exclusively for charitable purposes and which has tax exempt status under Section 501(c)(3) of the Internal Revenue Code and any applicable laws of the State of Florida.

IN WITNESS WHEREOF, I, MICHAEL D. MCADARAGH, the President of the Board hereby state and affirm that all known debts and liabilities of the corporation are provided for and paid. This plan of distribution has been adopted at a meeting of the board of directors upon receiving the vote of a majority of the directors in office.
