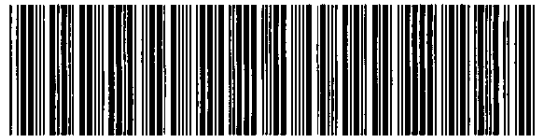

ARTICLE III, The specific purpose for which the corporation is organized is:

2. Specifically, helping under-privileged youth develop self-worth and discipline and respect for others through the sport of boxing in Brevard County, Florida, to lessen the burdens of government, and to combat community deterioration and juvenile delinquency.

ARTICLE IX, Dissolution

Upon dissolution of the organization as approved by the Board of Directors, all remaining assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, or shall be distributed to the federal government, or to a state or local government for public purpose.


