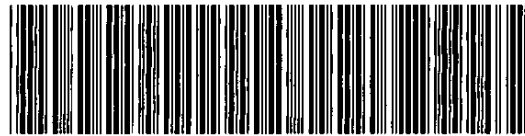



The undersigned, acting as incorporator of a corporation under Chapter 617 of Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I
Name & Address of Corporation

The name of the corporation is **Sisters With Voices Foundation, Inc.**, and the mailing address of the Corporation is 9932 Baywater Drive, Boca Raton, FL 33496-2142.

ARTICLE II
Duration

The term of existence of the Corporation is Perpetual.

ARTICLE III
Corporate Purpose

This Corporation is a not for profit corporation organized under Chapter 617, Florida statutes. It not organized for the private gain of any person. The object and purposes of this corporation shall be the support of religious, educational, charitable, and cultural purpose.

No part of the net earnings of the Corporation shall inure to the benefit of any member, trustee, officer of the Corporation, or any private individual, except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its purposes, no member, trustee, officer of the Corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation.

Notwithstanding any other provision of these articles, the Corporation is organized exclusively for charitable, educational religious, and cultural purposes as specified in section 501(c)(3) of the Internal Revenue Code, as amended, and shall not carry on any activities not permitted to carried on by a corporation exempt from federal Income Tax under section 501(c)(3) of the Internal Revenue Code as amended.

Upon the dissolution of the Corporation or the winding up of its affairs, the assets of the Corporation shall be distributed exclusively to one or more charitable, religious, testing for public safety, literary, or educational organizations which would then qualify under the provisions of Section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist or as they may be hereafter amended, or to the federal

government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IV

Members

The qualifications for members of the Corporation, and the manner of their admission, or appointment will be as set forth and regulated by the Bylaws of the Corporation, as amended from time to time.

ARTICLE V

Boards of Directors

The Boards of Directors of the Corporation shall be comprised of 6 members whose names are as follows:

Shelda Seche	Executive Director

The By Laws shall provide the method of election of all Directors, and the number of Directors may be raised or lowered by amendment of the Bylaw but shall in no case be less than three. The officers of the Corporation shall consist of a President, Vice-President, Treasurer, and Secretary. Other officers may be provided for in the Bylaws. Each officer shall be elected by the board of Directors (and may be removed by the Board of Directors) at such time and such manner as may be prescribed by the Bylaws.




