

The Undersigned acting as Incorporator of a Not-For-Profit Corporation under the Florida Not For Profit Corporation Act adopts the following Articles of Incorporation:

Article I.

NAME: The name of the Corporation is:

Article II.

Article III.

PURPOSE: The purpose for which Dee Chernicky Ministries, Inc. is organized is:

Section 111.01 To operate exclusively for charitable, educational, and religious purposes within the meaning of Section 501 (c) 3 of the Internal Revenue Code of 1986, or corresponding section of any future tax code and generally to engage in any other lawful endeavor or activity in furtherance of any of the foregoing purposes.

Section 111.02 To be a dynamic, multicultural, multiethnic, interracial and holistic ministry built upon the word of God.

Section 111.03 To minister to the hurting, wounded and broken while offering restoration and reconciliation with God.
