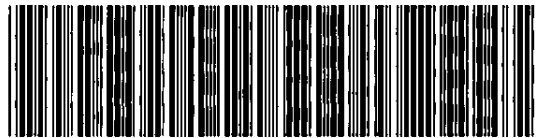

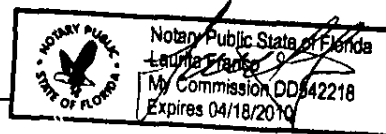

I, Sergio Padilla, the undersigned natural person of the eighteen years or older, acting as incorporator for the purpose of creating a non corporation under the laws of the State of Florida as contained in. Section 617.1503 (STATUE) entitled "No Corporation Act," and the general amendments thereto, do hereby set forth:

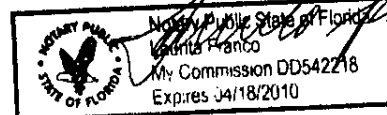

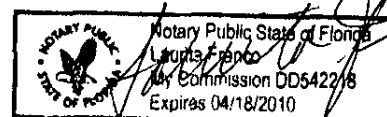
5) The directors of the corporation shall be elected or appointed in the manner and for the terms provided in the bylaws.

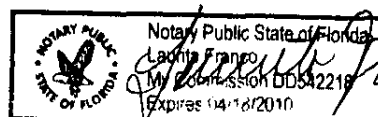

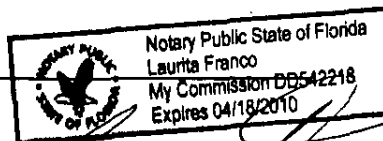
