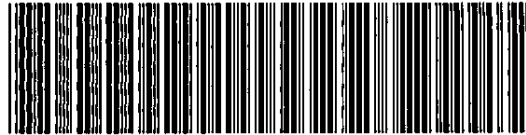

ARTICLE III

PURPOSES

The specific purpose for which this corporation is organized is:

GREATER TRINITY BAPTIST FELLOWSHIP CHURCH OF ORLANDO, INC. A BODY OF BAPTIST BELIEVERS CONVICTED BY THE HOLY SPIRIT TO BRING THE GOSPEL MESSAGE OF JESUS CHRIST TO ALL THAT DO NOT KNOW HIM. A Christian organization. GREATER TRINITY BAPTIST FELLOWSHIP CHURCH OF ORLANDO, INC Church Articles of Incorporation Amended

This corporation is organized exclusively for charitable, educational, religious or scientific purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code(or corresponding section of any future Federal tax codes).

This corporation is organized and operated exclusively for non-profit purposes and no part of any net earnings shall inure to the benefit of any member, director or officer. Notwithstanding any other provision of the Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 5 01 (c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code) or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code (or corresponding section of any future tax code).

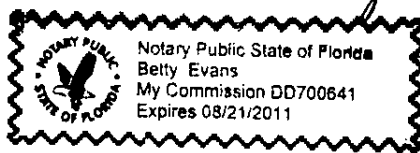
