Articles of Incorporation of the undersigned, civilian organization of women citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

FIRST: The name of the Corporation shall be American Legion Auxiliary Thomas-Fields Unit 217, Inc.

SECOND: The place in this state where the principal office of the Corporation is to be located is 341 Attapulguis Hwy, Quincy FL 32351 in Gadston County.
