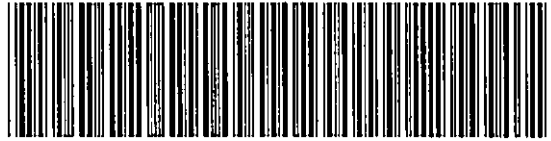

Article III is being amended to read: This corporation is founded exclusively for charitable religious purposes within the meaning of the IRS Code Sec 501(c)(3); namely : To establish and maintain a House of Chabad Orthodox Jewish Worship and there to provide Jewish religious, educational, cultural, and social and all other helpful services to the Jewish community according to Torah-Halachic tradition based on the Code of Jewish Law (Shulchan Aruch) by Shneur Zalman of Liadi and other canonical texts of traditional Judaism and Chabad customs. It will be empowered to contract, rent, buy or sell personal or real property, to provide a place of worship as well as a parsonage for the Chabad Emissary, Tzvi Dechter, who is the Rabbi and spiritual head of the organization and the final authority in all matters pertaining to Ethics, Spirituality and Religious Law. This corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of this corporation.

Upon the dissolution of the organization, its remaining assets shall be distributed for one or more organizations with similar exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code.

Rabbi Tzvi Dechter, being the appointed emissary of the world Chabad Chassidic movement, has the sole right to determine which question or issues should be regarded as matters of Ethics, Spirituality and Religious Law.

Article IV is being amended to read: The manner in which the directors are elected or appointed is as set forth in the bylaws namely, election by a majority of the directors upon nomination by the Rabbi.
