## GOLDEN OAK ESTATES PHASE I HOMEOWNERS ASSOCIATION, INC.,

a Florida Not-For-Profit Corporation

Pursuant to Section 617.1006 of the <u>Florida Statutes</u>, the undersigned not-for-profit corporation hereby adopts the following articles of amendment to its Articles of Incorporation:

FIRST: The name of the corporation is GOLDEN OAK ESTATES PHASE I HOMEOWNERS ASSOCIATION, INC.

**SECOND**: The Articles of Incorporation of this corporation are amended by changing Article 1 so that, as amended, said Article 1 shall read as follows:

#### ARTICLE 1

#### NAME

The name of the corporation shall be GOLDEN OAK PHASE I HOMEOWNERS ASSOCIATION, INC., a Florida not-for-profit corporation (the "Non-Residential Association"), whose principal address and mailing address shall initially be 1375 Buena Vista Drive, Lake Buena Vista, Florida 32830.
