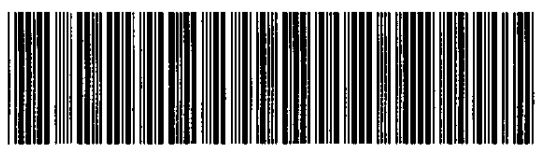

ARTICLE #3: The sole purpose is to spread the gospel of Jesus Christ. To do so we need to build a relationship with the people we support, the Homeless and Hurting. To build this relationship, we started by feeding them, as they have found that we have been there and will always be there; for them. We have built relationships with different county Service Providers, by doing this, we are able to get alcoholics off of the street into Detox and then into a treatment programs; and then help them change their lives. As these relationships are built, these "Street People" know that we truly care for them and their wellbeing, now we have to chance to truly lead them to Jesus Christ.

The above paragraph explains our way of reaching people. Some other services we provide, other than a "Rolling Soup Kitchen" are:

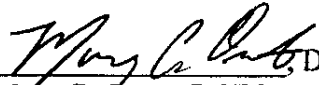
- a. A link between County Services and the people (a contact person)
- b. Transportation to and from medical and other services.
- c. A link between the people and there lost families.
- d. We are able to get homeless people off of the street and with the help of County Services, place them into Assisted Living Facilities.
- e. We operate a Food Pantry; where families can obtain "groceries", if they cannot make financial ends meet.

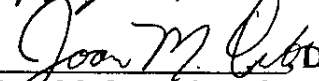
All of the above services are available to anyone in need, regardless of the person or situation; they will be made available to anyone and everyone. Everyone is eligible, they are not selected, if they have a need; it is offered. There are no fees/funds collected from the people, all of our services are offered free of charge. These services are provided every waking moment of every day, through out Palm Beach County and wherever we may be lead.

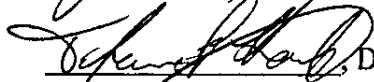
