

#### Article VI

Said CQM Kingfish Shootout, Inc. is organized exclusively for charitable, educational, religious, and/or scientific purposes within the meaning of section 501(c)3 of the Internal Revenue Code of 1986 (or corresponding section of any future Federal tax code).

No part of the net earnings of the CQM Kingfish Shootout, Inc. shall inure to the benefit of, or be distributable to, its members, trustees, directors, officers, or other private persons, except that the CQM Kingfish Shootout, Inc. shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of section 501(c)3 purposes.

No substantial part of the activities of the CQM Kingfish Shootout, Inc. shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the CQM Kingfish Shootout, Inc. shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of these articles, the purposes and activities of the CQM Kingfish Shootout, Inc. shall be limited exclusively to exempt purposes and activities within the meaning of section 501(c)3 of the Internal Revenue Code of 1986 (or corresponding section of any future Federal tax code).

Upon dissolution of this CQM Kingfish Shootout, Inc., assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)3 of the Internal Revenue Code (or corresponding section of any future Federal tax code) or shall be distributed to the Federal, State, or Local Government for a public purpose.
