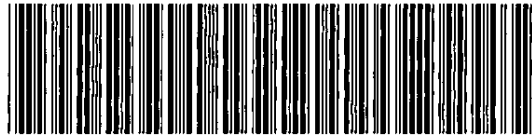

ARTICLE III- PURPOSE
