**ARTICLES OF INCORPORATION OF

The undersigned, acting as incorporator of 5000 ROLE MODELS EXCELLENCE PROGRAM, INC. under the Florida Not For Profit Corporation Act, adopts the following Article of Incorporation:

ARTICLE I. NAME

The name of the corporation is 5000 ROLE MODELS OF EXCELLENCE PROGRAM, INC., a Florida Corporation not for profit.

ARTICLE II. PRINCIPAL OFFICE

ARTICLE III. PURPOSE

This corporation is formed for such education and charitable purposes as will qualify it as an exempt organization under Section 501 (c) (3) of the Internal Revenue Code of 1986 corresponding provisions of any subsequent federal tax laws.

Within the scope of the foregoing, the corporation is specifically organized to promote to boost the self-image, social skills and academic performance of selected males, in part, by introducing and motivating them to interact with respected and successful role model men whose legitimate accomplishments can innovate and inspire them to achievements of their own; to intervene in the lives of "susceptible" youths to present them alternatives to violence and crime; to conduct fund raising activities to further the intervention and prevention activities of the corporation; and conduct all other activities consistent with its educational and charitable purpose to intervene in the lives of targeted youths in Pinellas County to inspire them to become successful and productive citizens of the United States of America.

ARTICLE IV. MANNER OF ELECTION

The membership of this corporation shall consists of all persons named as Directors and all other persons as, from time to time hereafter, may be elected to membership by the Board of Directors. Qualification for membership shall be satisfied by all persons expressing an interest in the purposes of the Corporation. The Directors shall from time to time prescribe the form and manner in which application may be made for membership, and members may be admitted by the Board of Directors only. The authorized number of the Members of the corporation, the

different classes of membership (if any), the property, voting and other rights and privileges of members, and their liability for dues and assessments and the method of collection thereof shall be set in the Bylaws.

ARTICLE V. INITIAL BOARD OF DIRECTORS

The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by Board of Directors. The method of election of directors shall be as stated in the Bylaws. The number of Directors of the corporation may be increased or diminished from time to time by the Bylaws but shall never be less than three (3). 
