ARTICLES OF INCORPORATION OF SECRETARY OF STATE MORNING STAR CATHOLIC SCHOOL - PINELLAS PARK, INOLL AHASSEE FLORIDA

The undersigned, being desirous of forming a corporation for charitable purposes under the provisions of Chapter 617 of the Florida Statutes, does agree to the following:

ARTICLE I NAME

The name of the corporation shall be Morning Star Catholic School - Pinellas Park, Inc., and its principal place of business and mailing address is 4661 80TH Avenue, Pinellas Park, Florida

ARTICLE II TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE III PURPOSES

The corporation is organized as a not-for-profit organization exclusively for religious purposes. The purposes of the corporation are:

- A. To carry out the teaching ministry of the Roman Catholic Church in the Diocese of St. Petersburg, Florida, United States of America, and to engage in all aspects of establishing, conducting and maintaining a Catholic learning institution for the instruction of Special Education students in religion, the arts, science, literature, and all branches of education, with authority to grant diplomas. In particular the corporation shall minister to the spiritual and temporal needs of people in strict accordance with the teachings, tenets, and policy of the Roman Catholic Church which is entrusted to the Bishop of the Diocese who is the person duly appointed, according to the norm of Canon Law and whom the governance of the Diocese is vested.
- B. To manage the temporal affairs of the corporation in such a manner that does not cause undue prejudice to the laws and disciplines of the Roman Catholic Church. To that end the corporation may establish, receive, maintain a fund or funds for the operational support of a Catholic School and may take and receive by gift, grant, bequest, devise, or otherwise any and all property of any sort or nature without limitation as to amount or value and to manage, administer, invest, reinvest, and dispose of the same; to administer endowment funds; from time to time, pay and apply other funds and property of the corporation, including the principal, as well as income thereof, for the support of the School.
- C. Subject to the limitations and conditions contained in any gift, devise or bequest received by the corporation, the corporation may invest its funds in such mortgages, bonds, debentures, shares of preferred and common stock, and other securities and property as its Trustees shall deem advisable.

ARTICLE IV POWERS

The corporation is empowered:

- A. To buy, own, sell, convey, assign, mortgage, lease, or encumber any interest in real property and personal property, and to construct, maintain and operate improvements thereon necessary or insistent to the accomplishment of the purposes set forth in these Articles of Incorporation.
- B. To borrow money and issue evidence of indebtedness in furtherance of any or all of the objects of the purposes described in these Articles of Incorporation and to secure the same by mortgage, pledge or other lien upon the corporation's profit.
- C. To the extent permitted by law, to do everything necessary or proper for the carrying out of the foregoing purposes.
- D. In the event of dissolution of the corporation or the winding up of its affairs, or other liquidation of its assets, the corporation's assets shall be distributed to organizations selected by the Member which have qualified for exemption under Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal Tax Code.
- E. Notwithstanding any other provisions of these Articles, this corporation will not carry on any other activities not permitted to be carried on by (a) a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law or (b) a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 or any other corresponding provision of any future United States Internal Revenue Law.
- F. The corporation is established as an apostolate of the Roman Catholic Church and as such, in accordance with canon law, the following rights are reserved to the Member:
 - 1. The operating philosophy, mission and values of the corporation shall be approved by the Member;
 - 2. Corporate property may not be sold, leased, encumbered, or otherwise alienated without the express written approval of the Member;
 - 3. The corporation may not be merged or dissolved without the express written approval of the Member; and
 - 4. Any additional rights as provided for in the Bylaws.

ARTICLE V MEMBER

The sole Member of this corporation shall be the Most Reverend Robert N. Lynch, as Bishop of the Diocese of St. Petersburg, and his successors in office. In the absence of the bishop, the diocesan administrators *sede vacante* shall assume the role as Member.

ARTICLE VI BOARD OF TRUSTEES

The business affairs of this corporation shall be managed by the Board of Trustees. The corporation shall have five Trustees, which shall be elected and serve as provided in the Bylaws of the corporation.

ARTICLE VII OFFICERS

Section 1. The officers of the corporation may include a Chairperson, one or more Vice Chairpersons, President, a Secretary, a Treasurer, any additional Assistant Secretaries or Treasurers, and such other officers as the Board of Trustees may be elected. from time to time. A person may hold more than one office at one time. A person need not be a Trustee in order to hold office.

Section 2. The officers shall be elected at the annual meeting of the Board of Trustees or as provided in the Bylaws. The Directors are elected as set forth in the Bylaws.

ARTICLE VIII BYLAWS

The Board of Trustees may adopt or amend the Bylaws for the conduct of the corporation's business and the carrying out of its purposes, subject however, to the prior approval of the Member of the corporation.

ARTICLE IX AMENDMENTS

These Articles of Incorporation may be amended only upon the approval of the sole Member of the Corporation.

ARTICLE X CONDUCT OF AFFAIRS

The business and affairs of the corporation shall be conducted in a manner consistent with the code of Canon Law, the religious directives of the Diocese of St. Petersburg, all applicable directives and teachings of the Roman Catholic Church, and the provisions of the Articles of Incorporation and Bylaws of this corporation.

ARTICLE XI LIMITATIONS ON ACTIVITIES

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except the corporation shall be authorized and

be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate or public office.

ARTICLE XII REGISTERED OFFICE AND AGENT

The street address of the registered office of this corporation is: 4514 Central Avenue, St. Petersburg, Florida 33711, and the name of the registered agent of this corporation at this address is Joseph A. DiVito, Esquire.

ARTICLE XIII INCORPORATOR

The name and address of the incorporator is Most Reverend Robert N. Lynch as Bishop of the Diocese of St. Petersburg, his successors in office.
