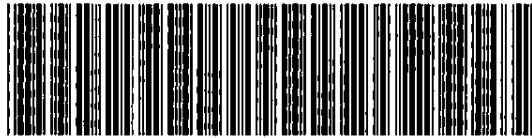

ONE: The name of this principal corporation is Stepping Forward Outreach, Inc. and the address is 2916 Orient Road Tampa, FL 33619-2506. The corporation is organized pursuant to the Florida Nonprofit Code.

TWO: This Corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. 
