# ARTICLES OF INCORPORATION OF HALIFAX AREA MINISTERIAL ASSOCIATION, INC.

a Florida not-for-profit corporation

#### ARTICLE 1. NAME

The name of this Corporation shall be: Halifax Area Ministerial Association, Inc.

#### ARTICLE 2. DURATION

The duration of this Corporation is perpetual. The date and time of commencement of the corporate existence is the time of filing of the Articles of Incorporation by the Department of State of the State of Florida.

### ARTICLE 3. PURPOSE

The purposes of the Corporation shall be exclusively charitable in nature, to-wit: To engage exclusively in activities for charitable, religious, or educational purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future federal tax code), and within these restrictions, to engage in activities including but not limited to advancement and fellowship of those in the ministry, advancement of religion, and advancement of education.

### ARTICLE 4. DISSOLUTION

Upon the dissolution of the Corporation the Board of Directors shall, after paying or making provisions for the payment of all of the liabilities of the Corporation, dispose of all of the assets of the Corporation exclusively for the purposes of the Corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable or educational purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future federal tax code), as the Board of Directors shall determine.

### ARTICLE 5. PRINCIPAL OFFICE AND REGISTERED AGENT

The street and mailing address of the principal office of the Corporation is c/o Rev. John Gill, Tomoka United Methodist Church, 1000 Old Tomoka Road, Ormond Beach, FL 32174.
