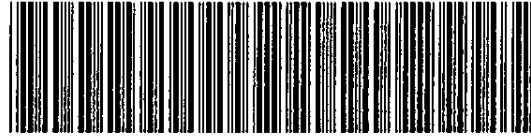

7. The corporation is organized and shall be operated exclusively for charitable, religious, educational, and/or scientific purposes within the meaning of section 501© (3) of the Internal revenue code, or corresponding section of the future federal tax code.
8.
