**ARTICLES OF INCORPORATION  
OF

***A Not for Profit Corporation***

In compliance with the requirements of F.S. Chapter 617, the undersigned, being a natural person and citizen of the United States, acts as incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a not for profit corporation.

**ARTICLE I  
Name**

The name of the corporation shall be: South Florida Baseball Coaches Association, Incorporated.

**ARTICLE II.**

The principal office of the Corporation is to be located in the City of Miami Lakes, in Miami-Dade County, Florida, and the mailing address shall be: 15130 Garvock Place, Miami Lakes, Florida 33016.

**ARTICLE III.  
Purpose**

This corporation is organized for the purpose of contributing joint efforts toward improving the athletic skills of high school competitors who wish to participate in the well loved American Sport of Baseball by inspiring them to practice physical fitness through vigorous training, achieve overall healthy living and the practice of good sportsmanship. In order to accomplish the above goals and at the same time provide an opportunity for competition among those who take the sport of baseball seriously, the coaches will plan games and tournaments to be played in safe environments that are also conducive to spectators.

In addition, the coaches will attempt to make parents, educators, and legislators aware of the importance of athletic competition among high school students, the benefits of which include: positive interaction and relationships with teammates; avoidance of harmful substances with a preference for good health; determination; motivation; emotional and attitude control; and better effort directed toward academic studies. In general, the coaches intend to promote a healthy lifestyle among young athletes who wish to play baseball, and stress the necessity of succeeding academically.

**ARTICLE IV.**

Earnings that may be derived from this corporation shall not inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the

corporation shall be authorized and empowered to pay reasonable compensation for services rendered, and to make payments and distributions in furtherance of the purposes set forth in Article III hereof

#### **ARTICLE V.**

##### ***Distribution of Assets upon Dissolution***

Upon the dissolution of the corporation, any assets acquired shall be distributed to one or more exempt purposes within the meaning of F.S.617. Any such assets not so disposed shall be disposed by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

#### **ARTICLE VI.**

##### ***Appointment of Directors/Officers***

The initial Board of Directors which will consist of three or more individuals who will be appointed by the Incorporators based on professional qualifications, skill, and ability as needed by the corporation. The total number of Directors, which shall never be less than three, will be established in the By-laws. The Directors will elect the Chairperson among themselves. Officers shall be nominated and elected by the Board of Directors.

#### **ARTICLE VII.**

##### ***Members***

This corporation shall have members which will be accepted in accordance with the rules set forth in the By-laws.
