ARTICLES OF INCOPORATION OF HARVEST HOUSE CHRIST CENTERED RECOVERY INC. (A Florida Corporation Not for Profit)

Article 1: NAME

The name of this Not for Profit Corporation is:

HARVEST HOUSE CHRIST CENTERED RECOVERY INC.

Article 2: ADDRESS OF PRINCIPLE OFFICE

The principle place of business and mailing address of the Corporation shall be: 8386 HOLLY HILL COVE, JACKSONVILLE FL 32221

Article 3: PURPOSES

This Corporation is a not for profit corporation and is not organized for the private gain of any person. It is organized under Chapter 617, Florida Statues exclusively for religious, benevolent, charitable, literary and educational purposes. The objective and purposes for which this corporation is constituted are:

- To disseminate the Gospel of Jesus Christ and the Word of God, to that end that
 people of God may be conformed to the image of Jesus Christ and to support and
 encourage communication and extension of the Christian life and witness by sound
 and comprehensive preaching, singing ministry and the teaching of the Holy Bible
 and of the Gospel of the Lord Jesus Christ to all men by all means which shall
 accomplish such communication.
- To regularly assemble together the members of this church in it's various locations for fellowship one with another and to worship God in spirit and truth and to bring both families and individual believers in the Lord Jesus Christ together in personal fellowship at various locations, both home and abroad.
- 3. To pray for the needs of men and for local and national leaders and governments.
- 4. To provide basic New Testament discipleship to believers on the domestic and foreign mission fields and to baptize by water and spirit; to anoint the sick with oil; to marry, dedicate infants; to celebrate the Lord's Supper and to bury.
- 5. To solve family and marital problems so that the home life of God's people is healthy and fruitful by Biblical standards.
- 6. To act with charitable concern and to help not only the members of this Christian community, but also to all men in need of any help which this church can give regardless of race, social position or religious affiliation and to develop and carry out programs of social action for poor, widowed, orphaned, afflicted, addicted, imprisoned, underprivileged or aged persons, both within and outside this corporation.

- 7. To facilitate the delivery of faith-based substance abuse services which are exclusively religious, spiritual, or ecclesiastical in nature and authorized by exemption from licensure pursuant Florida Statute 397.405 (8) and to further engage authorized service provider(s) licensed pursuant F.S. Chapter 397 to facilitate the delivery of certain licensable service components itemized under F.S. 397.311 (18) while retaining the aforesaid exemption with respect to services which are exclusively religious, spiritual, or ecclesiastical in nature in order to facilitate the delivery of a blended and complimentary service model utilizing faith components authorized under exemption in tandem with certain licensable clinical service components delivered by duly authorized service provider(s) under state licensure.
- 8. To seek out and engage public, private, community and governmental organizations in order to develop more effective and seamless inter-agency relations, communication, professional protocol and cooperative strategies in order to more clearly identify mutual objectives and concerns; to further facilitate by and through such cooperatives the development of mutual strategies toward the implementation and delivery of a greater variety of more comprehensive and viable alternative religious, ministerial, benevolent, charitable, literary and educational programs and services; to facilitate greater accessibility to faith oriented services and to carefully consider the matter of personal choice or preference through such provision of said alternative services.
- 9. To provide greater access to a broader and more comprehensive variety of alternative services and programs whether faith-oriented or blended models of faith-science cooperatives, programs and services; to further and specifically provide alternative programs and services for persons to whom faith may be a central component to or a critically important factor in individual success in program participation and completion; to provide such programs and services to certain persons and populations whom for whatever reason are unable to positively respond to or benefit from programs and services that are of an exclusively secular nature and to further provide for other such similar inter-agency and faith-community cooperatives and to specifically address and meet the spiritual, religious, ministerial, benevolent, charitable, literary and educational needs of certain economically disadvantaged populations
- 10. That it is the mission and objective of this corporation to both disseminate the Gospel of Jesus Christ and to provide religious, ministerial, benevolent, charitable, literary and educational opportunities to our community and to all men by all means ultimately intended toward improving the overall welfare of our local citizenry, our community, the city of Jacksonville, the State of Florida, the United States of America and throughout the World.
- 11. To recognize, support and cooperate with various ministries established by God to equip believers to fulfill their respective functions as members of the Body of Christ and to bring the whole body to maturity and completion; and to ordain ministers to assist in the establishment and maintenance of Churches, ministries and services; and to send forth missionaries for the establishment and upholding of their Churches; both domestic and foreign.
- 12. To provide both domestic and foreign missionaries with the funds and equipment that is needed to spread the Gospel throughout the earth; To receive donations from Corporations and persons for such purposes; and to provide legal tax deductions for Corporations and persons that make such donations.

Article 4: POWERS

The objectives and purposes for which the foundation is constituted and this Corporation organized are:

- 1. To provide a local church in all its fullness and all of its function in the United States with the home church being located in Jacksonville Florida
- To provide for missionaries desiring to serve in a foreign country; and to qualify for foreign governments as a non profit organization and comply with their laws and requirements.
- 3. To that end that the foregoing objectives and purposes and any related religious and charitable purposes may be carried out, performed and accomplished, this corporation shall have the power to engage only in such activities as shall not constitute business unrelated to its religious, benevolent, charitable, literary and educational purposes. It shall only engage in such activities as are permitted to be carried on by corporations whose income is exempt from taxation pursuant to Section 501(c)(3), and contributions to which are deductible pursuant to Section 170(c)(2), of the Internal Revenue Code of 1986, or corresponding provision of any future United States Internal Revenue Code. Any provision elsewhere in these Articles of Incorporation to the contrary not withstanding, this Corporation shall not engage in, nor shall any of it's assets be used or applied to, activities which constitute carrying on of propaganda, attempting to influence legislation, or participating in or intervening in any political campaign on behalf of any candidate for public office.
- 4. Subject to the foregoing limitations and subject specifically to the provisions of Section 617.0105 of the Florida Statutes, this corporation shall have the rights and powers set forth in section 617.021 of the Florida Statutes. The purpose set forth in Article 3 hereof shall likewise be construed as powers.

Article 5: BOARD OF DIRECTORS

The qualifications, manner of selection, duties, terms and other matters relating to The Board of Directors shall be set in the Bylaws of the corporation. The number of directors may be increased or decreased by amendment of the Bylaws. The number constituting the initial Board of Directors is three (3) and the names and addresses of these persons who are to serve are:

Article 8: MEMBERSHIP

This corporation is organized on a non-stock basis. The qualification of members and the manner of their admission shall be regulated by the By-laws

Article 9: TERM OF EXISTENCE

This Corporation shall exist perpetually unless dissolved according to law.

Article 10: DISSOLUTION

This Corporation may be dissolved only pursuant the agreement of the Board of Directors. Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principle office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.
