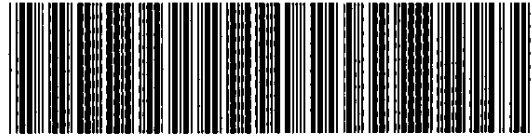

Please add Article IX (A) Upon dissolution of Ministerio Centro Cristiano NEFESH, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)3 of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose. Notwithstanding any other provision on this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from the Federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (SEE ATTACHMENT A2)

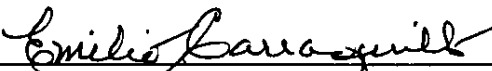
