ARTICLES OF INCORPORATION IN COMPLEX STATES OF INCORPORATION IN Compliance with Chapter 617, F.S., (Not for Profit)

Section 617,0202(d)

The number of directors of the Corporation shall be one, but the number thereof may be increased to not more than three, or decreased to not less than two, by amendment of these By-laws. The director(s) shall be elected at the annual meeting which shall be conducted on or around June 1st of each year. At each meeting of the officers for the election of director(s) at which a quorum is present, the vote required for election of a director shall, except in a contested election, be the affirmative vote of a majority of the votes cast in favor of or against such nominee. In a contested election, a nominee receiving a plurality of the votes cast at such election shall be elected. An election shall be considered to be contested if, as of the record date for such meeting, there are more nominees for election than positions on the Board to be filled by election at the meeting. The director shall hold office until the annual meeting which shall be held next after the election of such director and until a successor shall have been duly elected and qualified, or until death, or until the director shall have resigned as hereinafter provided in Section 10 of this Article III.
