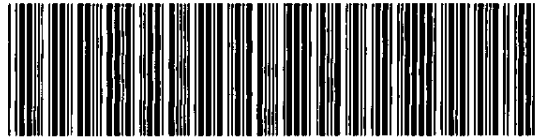

The undersigned, for the purpose of forming a Not-For- Profit Corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation.

Article I.
Name

Wounded Women Warriors International Ministries, Inc. (Hereinafter called the "Corporation").

Article II.
Principal office and Mailing address of the Corporation

Article III.
Purpose

The specific purpose of this Not-for-Profit Corporation is for the Charitable, religious and educational Training purposes in Section 501(c)3 of the Internal Revenue Code 1986 and for the purpose of engaging in any lawful act or activity not for perusing profit for which Not-For- Profit Corporation may be organized, so far as is or may be permitted by laws of the State of Florida and Section 501(c)3of the Internal Revenue Code 1986 as amended, **Wounded Women Warriors International Ministries, Inc.** Also there will be several religious programs/projects organized to operate through Wounded Women Warriors International Ministries, Inc. 24 hour prayer line, Motivational Speakers, Workshops, Retreats, Spiritual Growth and development(S.G.A.D.) Gospel Performing Arts (G.P.A.) Family Outreach Program(F.O.P.) Community Consulting Services (C.C.S.) Mother Daughter Empowerment Program (M.D.E.P.) Career Development Program (C.D.P.) Wounded Women Warriors Network(W.W.W.N.) Seminars, Grief Support Outreach Services(G.S.O.S.) Women and Children Connection (W.C.C) Speak a Word Outreach(S.A.W.O.) Diamond in the Rough (D.I.T.R.)Conferences, Drama Enrichment Training (D.E.T.) Gospel Comedy Outreach (G.C.O.). Health Awareness Outreach(H.A.O.) Grandparents Assistance Program (G.A.P.) Healing Our Wounds Outreach (H.O.W.O.) **Adolescents Learning To Overcome Negativity (A.L.T.O.N.)** , Parent to Parent Activity Program (P2 P.A.P.) etc.

Article IV.
Membership

Any person, relative, corporate, partnership, association or organization who is interested in the purpose of the corporation, who is capable of contributing to the achievement of those purposes and the effective operation of the corporation, and who complies with the requirements established from time to time by laws shall be eligible for membership.

Article V.
Initial Registered office Agent

The street address of the initial registered office of the corporation is 1604 River Reach Drive Apt .97 Orlando Florida 32828

Article VI.
Board of Directors

The officers of this corporation shall be managed by a Board of Directors consisting of no more than ~~Eight (8)~~ ^{Eight (8)} directors. The number of directors may be increased or decreased from time to time, in accordance with the by-laws of the corporation, but shall never be less than ~~4~~ ⁴ (2). The manner of election of Directors shall be regulated by the by-laws.

Article VII.
Incorporator

Article VIII.
Dissolution

Upon the dissolution or wending of this Corporation, its assets remaining after payment or provisions for payment of all debts and liabilities of the corporation shall be distributed to a not-for-profit fund, foundation or corporation, which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under section 501(c)3 of the Internal revenue Code 1986, as amended or corresponding provisions of any subsequent federal tax laws.

Article IX.
Limitations

No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its directors, officers, members or other private person except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payment and distributions in furtherance of it's purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislations (except as otherwise provided to subsection (h) of section 501(C)3of The Internal Revenue Code 1986, as amended), and the corporation shall not participate or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry in any activities not permitted to be carried on (a) by Corporation exempt from federal income tax under section 501(C)3 of the Internal Revenue Code 1986, as amended(or the corresponding provision of any future United States Internal revenue law) or (b) A corporation, contributions to which are deductible under section 170 (c) of The Internal revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law).
