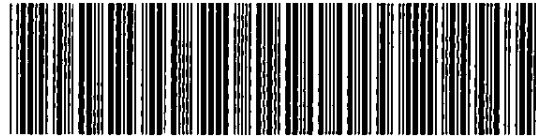

ARTICLE I - NAME: The name of the corporation shall be HUDAW, INC.

ARTICLE II - CORPORATE EXISTENCE:

The corporate existence of this corporation shall commence with the filing of the Articles of Incorporation and shall it shall exist perpetually thereafter.

ARTICLE III - PRINCIPAL OFFICE:

**The principal street address and mailing address of this corporation shall be:
13900 CR 455, Suite 107-118, Clermont, FL 34711**

ARTICLE IV – PURPOSE:

(a) The corporation is organized and will be operated exclusively to carry out the charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provisions of any future United States Internal Revenue Laws to engage in activities relating to the aforementioned purposes; and to invest in, receive, hold, use and dispose of all property, real or personal, as may be necessary or desirable to carry into effect the aforementioned purposes.

(b) In furtherance of the aforementioned purposes, the Corporation's purposes shall include the following: to establish a place to worship Allah as the only God, to encourage practice of Islam in its entirety, to solicit everyone to help us distribute Allah's words to mankind, to propagate the concept of the equality of mankind since all of us are descendants of Adam, to live in peaceful co-existence among each other, to respect the right of everyone to worship as they choose, to promote greater understanding of our belief to others through education, community service and outreach programs, and to perform all such lawful acts that shall aid in the achievement of these objectives and purposes.

(c) Notwithstanding any other provisions of these articles of incorporation, the corporation shall not carry on any activities not permitted to be carried on: (i) by a corporation exempt from Federal income tax under Section 501(c) (3) of the Internal Revenue Code or (ii) by a corporation, contributions to which are deductible under Sections 170(c) (2) and 2522(a) - (2) of the Internal Revenue Code.

ARTICLE V - CORPORATE STRUCTURE:

The corporate structure shall consist of a Board of Trustees, comprising of three (3) members, and a Board of Directors with at least three (3) members.

ARTICLE VI - MANNER OF ELECTION:

The manner in which the Directors are elected or appointed is through appointment.

ARTICLE VII - BOARD OF TRUSTEES:

The Board of Trustees shall consist of three (3) members, and the first Board of Trustees shall consist of the three founding members of the corporation, who shall occupy the positions of President, Secretary and Treasurer respectively. If a position becomes vacant on the Board of Trustees, the other two members shall approve any candidate to fill that vacancy on the Board of Trustees.

The Board of Trustees shall be the highest authority in the organization and it shall appoint a Board of Directors and various committees to run the organization. The Board of Trustees shall supervise and may dissolve the Board of Directors and various committees, as it sees fit. In case of any disagreement, the President of the Board of Trustees shall have the final authority in decision making and he/she shall be entitled to the full support of the other two members of the Board of Trustees in the furtherance of the objectives of the corporation. ARTICLE VIII - BOARD OF DIRECTORS:

The corporation shall have at least three (3) Directors. The number of Directors may be increased or decreased from time to time by the Board of Trustees. The Directors shall carry out the day to day operations of the corporation, under instructions of the Board of Trustees. In the case of a dispute, the Board of Directors shall acknowledge the President of the Board of Trustees as the final authority in all matters concerning the affairs of the corporation.

ARTICLE XI - AMENDMENT:

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved at a meeting of the Board of Trustees, who shall state their intention that a certain amendment of these Articles of Incorporation be made.

ARTICLE XII – ACTIVITIES:

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE XIII – DISSOLUTION:

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose, Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
