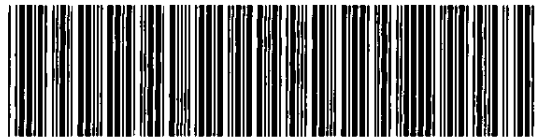

Articles of Incorporation of Change Starts Now, Inc.

The undersigned person, acting as incorporator, hereby establishes a nonprofit corporation pursuant to the Florida Nonprofit Corporation Act and adopt the following articles of incorporation:

Article I- NAME

The name of the corporation is Change Starts Now Inc.

Article II-PLACE

The principle place of business and mailing address is 641 Childers Street Pensacola, Florida 32534

Article III-PURPOSE

3.1 The corporation, is organized and shall be operated exclusively for charitable, religious, and educational purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code. The specific purposes and objectives of the corporation shall include but not be limited to the following:

3.2 Notwithstanding any other provisions of these Articles of Incorporation:

- a. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its directors, officers or other private persons, except that this Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.
- b. No substantial part of the activities of the Corporations shall be the carrying on of propaganda, or otherwise attempting to influence legislation, (except as otherwise provided by Section 501 (h) of the Internal Revenue Code), and the corporation shall not participate in, or intervene in (including the publication and distribution of statements) and political campaign on behalf of any candidate for public office.
- c. The Corporation shall not conduct or carry on any activities of the Corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by:
 2. An organization exempt from taxation under Section 501 (C) (3) of the Internal Revenue Code and its regulations as they now exist or as they may hereinafter be amended, or
 3. An organization, contributions to which are deductible under 170 (C) (2) of the Internal Code and its regulations as they now exist or as they may hereinafter be amended.
- d. Upon dissolution of the Corporation or the winding up of its affairs, the assets of the Corporation shall be distributed exclusively to charitable organizations which would then qualify under the provisions of Section 501 (C) (3) of the Internal Revenue Code and its regulations as they now exist or as they may hereafter be amended.

Article IV- MANNER OF ELECTION

The manner in which the directors are elected or appointed shall be provided in the Corporation's Bylaws.

Article V-INITIAL DIRECTORS AND/OR OFFICERS

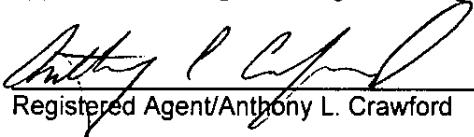

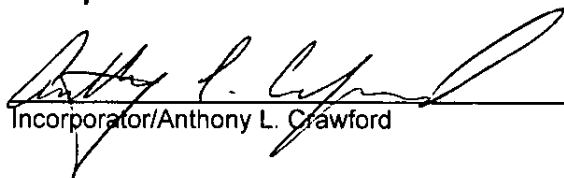
