## AMENDMENT TO ARTICLES OF INCORPORATION

HEART OF PUTNAM FOOD PANTRY INC., having corporation number N09000006319, amends the following section of its Articles to reflect the following updates:

Adding Article VIII-Dissolution and Article IX Amendment to By-Laws:

### **Article VIII-Dissolution**

Upon the dissolution of HOPFP, assets shall be distributed for one or more exempt purposes within the meaning of section 501 © (3) of the IRS Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

## **Article IX-Amendment to By-Laws**

Any of these Bylaws may be amended, altered, repealed or added to, and new By-laws may be made, by the affirmative votes of two-thirds (2/3) of the membership of the Board, at any given meeting of the Board of Directors. The proposed change shall be provided to the Board in writing, or via electronic transmission, seven (7) days prior to proposed action.
