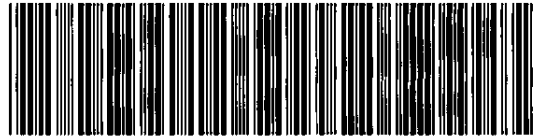

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE 1. Name: The name of the Corporation is: A.T. Jones Math, Science & Technology Academy, Inc.

ARTICLE 2. Duration: The duration of the Corporation is perpetual.

ARTICLE 3. Purpose: The general purposes for which the Corporation is organized are the following:

- A. To engage in and transact any lawful business for which nonprofit educational organizations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of the nonprofit educational organization or necessary or desirable in order to accomplish them.

ARTICLE 4. Initial Office and Registered Agent. The street address of the initial Principal Office of the Foundation is: 4903 Ehrlich Road, Tampa, FL 33624. The name of the initial Registered Agent is Arthur T. Jones.

ARTICLE 5 Members /Stock  
The corporation shall have members. The corporation shall not have any class of stock.

ARTICLE 6. Initial Board of Directors: The number of Directors constituting the initial Board of Directors is 3. The number of Directors may be increased or decreased from time to time in accordance with the Bylaws but shall never be less than two. The name and address of the initial Directors of the organization is as follows:


