The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation is **SOCIETY OF YOUNG BUSINESS PROFESSIONALS, INC.**

ARTICLE II: PRINCIPAL OFFICE

The principal address of the corporation shall be 2190 Commercial Way, Spring Hill, Florida 34609.

ARTICLE III: PURPOSE

This corporation does not contemplate pecuniary gain or profit to its members. The specific purpose for which it is formed is to foster strong business relations among business professionals in Hernando County, Florida, and encourage positive community involvement, leadership, and professional growth in the community at large.
