Articles of Incorporation

Article I

The name of the corporation shall be:

Olive Branch International Outreach Ministries, Incorporated.

Article II

The principal place of business and mailing address of this corporation shall be:

3302 Evergreen Avenue, Jacksonville, Florida 32206.

Article III

The duration of the corporation shall be perpetual.

Article IV

The purposes for which the corporation is organized are: to operate exclusively to facilitate peace, harmony and understanding between the family, school, and community.

To educate, instruct, and mediate in all areas pertaining to the health and well being of the youth of the community.

To build character and positive self image

Encourage continuance of education as a tool against poverty & ignorance

Increase parental knowledge of the process as a means of instilling change in the current academic environment

Insure that each parent understands his/her rights to assure a proper education and the process it involves.

Assist the school in its education endeavors and offer tutoring and other resources that will prove helpful to the education process

To raise funds for programs and development and continuation of services for the corporation in accordance with and in addition to the powers conferred by the laws of the State of FLORIDA, the Non-profit Corporation shall have the following powers:

- To receive and accept gifts of money and property and hold the same for any of the purposes of the Corporation and its work.
- To raise and assist in raising funds for the purposes herein set forth, including issuance of bonds or other instruments of credit.
- To acquire, own, lease, mortgage, and dispose of property both real and personal.
- To acquire and hold such property, either real or personal as maybe necessary for the corporation purposes.
- To provide services and instruction via the public media, including the internet, AM and FM radio, telecasting, closed circuit transmission, and cable television.
- To acquire, own and operate such broadcasting and/or telecasting facilities.
- To accept property and donations in trust for religious or charitable purposes.

Article V

The Board of Directors shall manage the business and property of Olive Branch International Outreach Ministries, Incorporated. The present Directors shall hold offices until further election. In the event of the inability of any Director to act, or in the event of the death of a Director, the remaining Directors shall elect another Director to fill the vacancy or vacancies, thus created. Each Director shall be a member in good standing of the corporation who ascribe to the same creed.

The Board of Directors shall be three or more in number and are the same as the original incorporators; their names and addresses are as follows:

Article VI

The Directors of the Olive Branch International Outreach Ministries shall be chosen by the founders initially and shall be a President, (2) Vice-Presidents, a Secretary and a Treasurer. The Board of Directors may combine any office except President and Treasurer. The Board of Directors may also appoint one or more Vice-Presidents and one or more Assistant Secretaries and Assistant Treasurers.

Article VII

The Board of Directors shall reserve the right to amend the Articles and By-laws by a majority vote. This may be done from time to time to further meet the needs of the Olive Branch International Outreach Ministries, Incorporated.

Article VIII

There shall be but one class of membership in this corporation. Membership in the Olive Branch International Outreach Ministries may be obtained by natural persons of all races, creeds, and colors, who shall publicly profess their belief in the corporation's creed. Furthermore, these persons shall profess their belief in the purposes of this organization as set forth herein above and who shall thereafter be accepted into membership in such a manner as provided by the Board of Directors of this corporation.

Article IX

In the event of the dissolution of this corporation, or in the event it shall cease to carry out the objectives and purposes herein set forth, all of the business, property and assets of the corporation shall be go and be distributed to such non-profit corporation qualifying as an organization exempt under the provisions of Section 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1986, or corresponding sections of any prior or future Internal Revenue Code, or Federal, State, or local government for exclusive public purposes, as the directors of the corporation may select and designate; and in no event shall any of said assets or property, in the event of dissolution thereof, go or be distributed to members, either for the reimbursement of any sum subscribed, donated or contributed by such members, or for any other such purpose. Any remaining assets should be sold and all the debts be satisfied; with the residual being donated to designated 501 (c) (3) corporation.

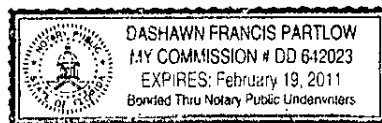
