ARTICLE III - Management of the Corporation shall be vested in the Corporation's Board of Trustees whom are the
Directors. The number of Trustee Directors shall not be less than three and no greater than five. Any action required
or permitted to be taken by the Board of Trustees, under any provisions of the law, may be taken without a meeting, if
at least two thirds of the Trustee's shall individually or collectively consent in writing to such action. Such written
consent shall be filed with the minutes of the proceedings of the Board of Trustees. Any such action by written consent
shall have the same force and effect as if taken by a unanimous vote of the Board of Trustees. Any certificate or other
document filed, under any provision of the law which relates to the action so taken, shall state the action was taken by
the unanimous written consent of the Board of Trustee in a meeting or without a meeting, and that these Articles of
Incorporation authorize the Board of Trustees to so act. Such a statement shall be prima facia evidence of such authority.
Any new project or projects, construction of such projects, and the securing of financing for such projects, will be handled
by a Trustee. Collecting of funds and spending of those funds will be handled by a Trustee. Selection of project related
architects, engineers, builders, etc. will be performed by a Trustee. The Imam can only be hired or terminated by the
Trustee.
