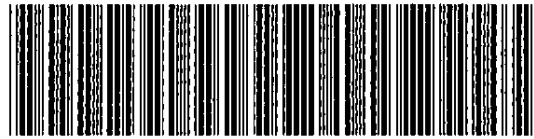

**ARTICLES OF INCORPORATION**

In compliance with the requirements of Chapter 617, Florida Statutes, the undersigned hereby acts as incorporator in adopting and filing these Articles of Incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the corporation shall be: **GREEN COLLAR TASK FORCE JOINT APPRENTICESHIP AND TRAINING COMMITTEE, INC.**

**ARTICLE II**

The principal street address of the corporation is: 3855 South U.S. Highway 1, Fort Pierce, Florida 34982.

The principal mailing address of the corporation is: 1003 Belvedere Road, West Palm Beach, Florida 33405

**ARTICLE III**

The object and purpose of the corporation is to provide job training and education opportunities through apprenticeship programs designed to train and educate the work force of the Treasure Coast of the State of Florida in the provision of the skilled trades of the various labor organizations which compose this corporation, improve the grade of product produced by such workforce, develop a higher degree of efficiency in the various occupations of the workforce, and to promote the use of "green" technologies by such workforce through approaches in design, construction, and renovation that incorporate materials and skills used to enhance energy efficiency and sustainable building development.

**ARTICLE IV**

a) The Board of Directors of the corporation shall be composed of one representative of each labor organization who is a member of the corporation. Initially, the Board of Directors shall be composed of five (5) members as indicated below. These members are representatives of the Sheet Metal Workers Local Union No. 32, Ironworkers Local Union No. 402, Carpenters District Council No. 79, International Association of Heat and Frost Insulators and Allied Workers Local No. 60, and the Painters and Allied Trades District Council No. 78.

b) The Board of Directors shall have the authority to approve additional members in accordance with the corporate By-Laws to be adopted at the organizational meeting of the Board of Directors. All additional members of the corporation must be a labor organization or an employer or association of employers operating in the same industries as the member labor organizations.

c) No member of the corporation who shall cease to be a member for any reason, shall be deemed to have acquired or continue to hold or maintain any right, claim or interest in and to the said corporation or any of the property, either real or personal, tangible or intangible, or otherwise acquired by this corporation by virtue of his membership in said corporation.

#### ARTICLE V

The initial board of directors shall consist of five (5) members. This number may be increased or decreased from time to time in accordance with the corporate By-Laws, but shall never be less than one. The names and addresses of the persons who will serve on the initial board of directors are:

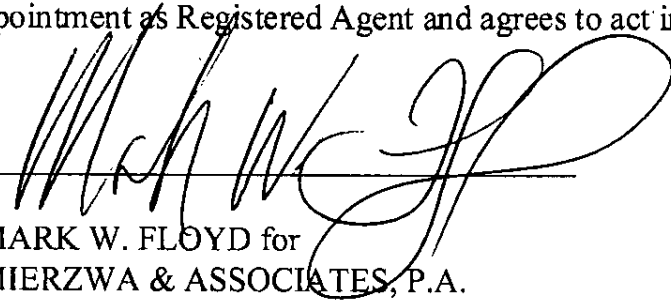

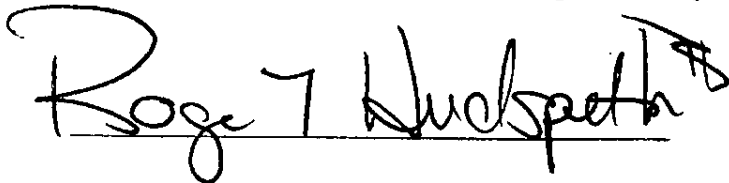
