

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF THE DEAN HEDSTROM FOUNDATION FOR MELANOMA AWARENESS, INC.

Pursuant to the provisions of section 617.1006 of the Florida Statutes, The Dean Hedstrom Foundation for Melanoma Awareness, Inc. adopts the following amendment to its Articles of Incorporation:

Article VIII

Upon the dissolution of this Foundation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this Foundation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose, such distribution shall be made in accordance with all applicable provisions of the laws of the state.

The date of adoption is March 5, 2010.

The effective date will be the date of filing.

There are no members of the Foundation entitled to vote on the amendment. The amendment was adopted by the board of directors.
