We the undersigned with other persons being desirous of forming a corporation for non profit purposes, under the Florida Non Profit Corporation Act, pursuant to chapter 617.0501, and 617.0202 Florida Statutes, adopt (s) the following Articles of Incorporation.

**ARTICLE I - NAME**

The name of the corporation shall be: CONCIENCIA NACIONAL DOMINICANA, INC.

**ARTICLE II - LOCATION**

The principal place of business and the mailing address of this corporation shall be :  
4404 Lakemont Ct. West Palm Beach Florida 33401.

**ARTICLE III – PURPOSES**

The general nature of the objects and purposes of this corporation shall be the follows: To conduct cultural awareness of the Dominicans people within the United States and to make conscience of all our social, cultural and political responsibility with our native country, in order to maintain live our values as a Dominican native.

## **ARTICLE VIII – BOARD OF DIRECTORS.**

## **ARTICLE IX – BY-LAWS.**

The Board of Directors of the corporation may provide such by-laws for the conduct of the activities and business and the carrying out its purpose as they may deem necessary from time to time. Upon proper notice by-laws may be amended, or altered by the majority of those members of the Board of Directors present at any regular meeting or any special meeting called for that purpose.

## **ARTICLE X – AMENDMENTS**

These Articles of Incorporation may be amended at a special meeting of the membership calling for that purpose, by 51% vote of those present. Amendments may also be voted at a regular meeting of the membership upon notice given, as provided in the by-laws of intention to submit such amendments.

## **ARTICLE XI - NON-PROFIT STATUS**

Notwithstanding any other provisions of the articles, the corporation is organized exclusively for one or more of the purpose as specified in Section 501 (c) (3) of the Internal Revenue Code of 1986, and shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal Income Tax under IRS Section 501 (c) (3) or corresponding provisions of any subsequent Federal Tax Laws.

No part of the net earnings of the corporation shall inure to the benefit of any individual or member, trustee, directors or officer of the corporation, and not member, trustee, officer or director of the corporation shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation.

The corporation shall not carry on propaganda or otherwise act to influence legislation.

## **ARTICLE XII – DUES**

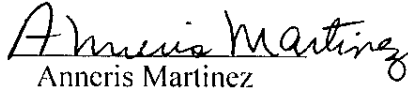
There will be no requirements for members of the Board of the membership to pay dues.

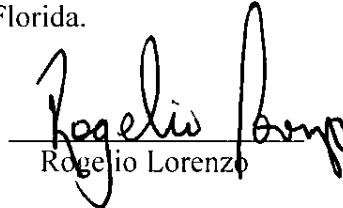
## **ARTICLE XIII - LIMITATION OF CORPORATE POWERS**

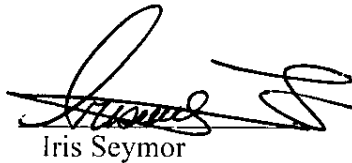

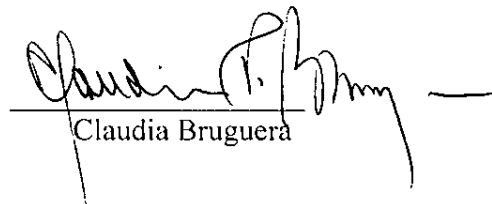
The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows: as Florida Statutes provide.
