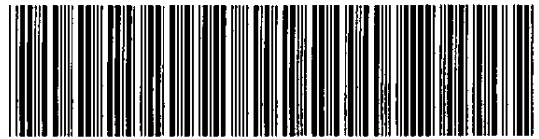


**ARTICLE IX**
