ARTICLES OF INCORPORATION OF LIVING ONLY TO SEE THE THRONE, INC. A FLORIDA NONPROFIT CORPORATION

Article 1. Name. The name of the Corporation is: Living Only to See the Throne, Inc.

Article 2. Duration. The duration of the Corporation is perpetual.

Article 3. Purposes. The purpose of the Corporation is as follows:

- A. This Corporation is a not-for-profit religious organization, organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purpose of this Corporation is to focus on spiritual growth and restoration of the total man-mind, body, and spirit. We are specifically geared to reach young adults.
- B. To exercise all rights and powers conferred by the laws of the State of Florida upon non-profit Corporations.
- C. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501©(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- D. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of 501 © (3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal Tax Code, or shall be distributed to the Federal, state, or Local Government for a public purpose. Any such assets not so disposed of shall be disposed of by a Count of competent jurisdiction of the County in which the principal office of the organization is then located, exclusively for such purposes.

Article 4. Members. The Corporation shall have Voting Members, who shall be elected (and may be removed) by the Voting Members, and who shall have all the rights and privileges of members of the Corporation. The Bylaws may provide for Non-voting Members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are setforth in the Bylaws, but who shall not have the right to vote.
