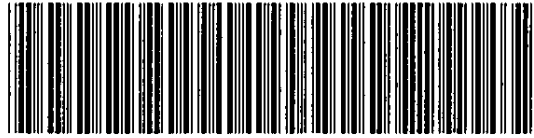

No part of the net earning of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in futherance of the purpose of this corporation.

Patriot Service Dogs, Inc is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501c3 of the IRS code or the corresponding sections of any future federal code. No substantial part of the activities of the corporation shall be the carrying of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activity of exercise any powers that are not in furtherance of the purpose of this organization.

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purpose within the meaning of section 501c3 of the IRS code, or the corresponding (con't)

sections of any further federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purpose. Any such assets not so disposed of shall be disposed by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.

Patriot Service Dogs, Inc purpose shall be to place well trained service dogs with individuals with mobility impairments. Our primary goal is to place service dogs with veterans with disabilities. Our secondary goal is to place well trained service dogs with Florida Residents with disabilities. It is our additional goal to educate the general public about the rights of service dogs, trainers and working teams, while focusing on giving individuals with disabilities back some of their independence.
