Purpose Clause - The organization is organized exclusively for charitable, religious, educational and scientific purposes under section 501(c) (3) of the Internal Revenue Code or corresponding section of any future federal tax code.

Dissolution Clause - Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue code, or shall be distributed to the federal government, or to a state or local government for a public purpose.

Article VIII added - Dedication of Assets

Upon dissolution of the organization, all assets of the organization
after the settling of all debts, shall be distributed for one or more
exempt purposes within the meaning of Section 501(c)(3) of the Internal
Revenue Code, or corresponding section of any future Federal tax code,
or shall be distributed to the Federal, State or Local government for
a public purpose. Any such assets not disposed of shall be disposed of
by a court of competent jurisdiction of the county in which the prin-
ipal office of the organization is then located, exclusively for such
purposes.
