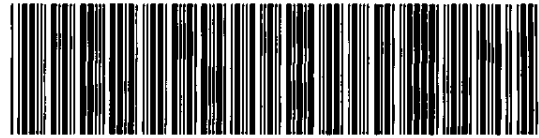

WHEREAS, it is deemed to be desirable and in the best interests of this board and its members that it be incorporated pursuant to the State Non-Profit Corporation Act. Be it resolved that the undersigned acting as incorporations of a State corporation under the State Non-Profit Corporation Act, adopt the following Articles of Incorporation for such corporation.

**Article I  
Name and Location**

The name of this corporation shall be called Kingdom Network Empowering Communities Inc. The street address of the principal location of this corporation shall be: 5928 Gilliam Rd. Orlando, FL 32818. The mailing address of this corporation shall be: P.O. Box 683576 Orlando, FL 32868.

**Article II  
Duration**

The corporation shall have perpetual existence and will commence on the filing of these articles by the Department of State.

**Article III  
Purpose**

The purpose of Kingdom Network Empowering Communities Inc. is to help people develop community programs. The community programs will pursue efforts to combat crime and promote crime prevention, provide training and mentoring for young people, promote education and community collaboration. The KNEC is organized exclusively for charitable and educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986. Its mission is to teach, promote, and enrich the educational, benevolent, social, cultural and economic well being of its members and community as a whole.

**Article IV**

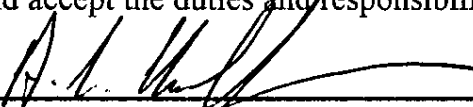
**Article V**

**Article VII**  
**Tax-Exemption Provisions**

No part of the net earnings of the Kingdom Network Empowering Communities Inc. shall inure to the benefit of or be distributed to its Board Members, Officers, staff, or other private persons, except that the KNEC Treasurer shall be authorized and empowered to pay reasonable compensation for the services rendered and to make payments and distributions in furtherance of

the purposes set forth in the KNEC's Bylaws. No substantial part of the activities of the KNEC shall be the carrying on of propaganda or otherwise attempting to influence legislation. KNEC shall not participate in, nor intervene in (including the publishing or distribution of statements), any political campaign on behalf of any candidate for public office.

## **Article VIII**

### **Conduct of Corporate Affairs**

The conduct of the affairs of the Corporation will be limited as outlined in the Bylaws of the Corporation. The powers of the Corporation are to be regulated as outlined in the Bylaws of the Corporation. The manner in which directors are elected or appointed will be as provided in the Bylaws of the Corporation.

## **Article IX**

### **Dissolution of Corporate Affairs**

If this KNEC Community Organization dissolve all of its assets remaining after payment of all outstanding debts and obligations, costs, and expenses of such dissolution shall be distributed to such nonprofit organization or organizations organized and operated exclusively for Crime Prevention, Performing Arts & Education purposes as shall at the time qualify as an exempt organization or organizations under Section 501 (c) (3) or the Internal Revenue Code of 1986 or any regulations succeeding said Section.

Board Members of Kingdom Network Empowering Communities Inc. defined in Bylaws, who are members in good standing at the time of the dissolution of KNEC shall, in a called meeting, designate the non-profit organization(s) to receive said assets of KNEC after dissolution

## **Article X**

### **Amendments to Articles of Incorporation**

The Articles of Incorporation may be amended by a two-thirds (2/3) vote of the Executive and Committee Board members present and voting when the members of the Corporation are meeting in conference as provided in the Bylaws of the Corporation.

## **Article XI**

### **Qualifications For Membership**

### Qualifications For Membership

The qualifications for membership in the Corporation and to serve as a director of the Corporation are stated in the Bylaws of the Corporation. Directors shall be elected or appointed in accordance with the Bylaws of the Corporation.

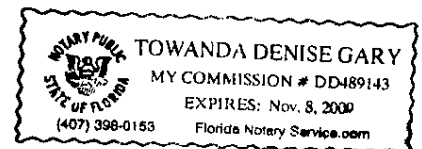
