# ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF NORTH OKALOOSA SPRING FESTIVAL, INC.

The undersigned individuals, on behalf of themselves and of all other individuals who may become members of this corporation, hereby associate themselves and their successors for the formation of a corporation, not for profit, under the laws of the State of Florida, and hereby make and adapt the following Articles of Incorporation.

#### ARTICLE I

The name of the Corporation shall be: North Okaloosa Spring Festival, Inc.

#### **ARTICLE II**

The principle office of the Corporation shall be located at: 2259 W. James Lee Blvd., Crestview, FL 32536. This shall also be the mailing address of the Corporation.

#### ARTICLE III

- a) The Corporation is organized to operate exclusively for charitable purposes; for the prevention of cruelty to animals and the promotion of animal adoptions. A portion of all contributions received, toward the organization of the festival and Community events, will be donated to one or more qualified exempt organization(s) who share this cause. The remaining portion of these contributions will be used for the purpose of organizing the events. One hundred percent (100%) of all contributions received for the sole purpose of the prevention of cruelty to animals and the promotion of animal adoptions will be donated to the qualified exempt organization(s).
- b) Other community events, such as a youth fishing tournament, will also be held annually. There will be no entry fee to participate in the fishing tournament, and prizes will be awarded in each age division.

The management of the Corporation and the direction of its work shall be vested in an Executive Board consisting of not less than four (4) qualified members and not more than seven (7), who shall be elected to serve until replaced or until the next annual election. The manner in which the Directors will be elected shall be further described in the By-Laws.

#### **ARTICLE VI**

#### **ARTICLE VII**

Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose.
