ATTACHMENT TO AMENDMENT TO ARTICLES OF INCORPORATION OF JAEB CENTER RESEARCH TRUST, INC., A FLORIDA NONPROFIT CORPORATION

1. Article Four of the Articles of Incorporation shall be deleted in its entirety and replaced with the following:

ARTICLE FOUR - PURPOSE

The purposes for which the Corporation is organized are to receive and hold assets, subject to the restrictions and limitations bereinafter set forth and to use and apply the whole or any part of the income therefrom and the principal thereof exclusively for charitable, religious, scientific, literary, or educational purposes either directly or by contributions to Florida organizations that conduct medical research related to eye diseases and/or diabetes that qualify as exempt organizations under Section 501(c)(3) and either Section 509(a)(1) or Section 509(a)(2) of the Internal Revenue Code and Regulations issued pursuant thereto as they now exist or as they may hereafter be amended.

In supporting the organizations described above, the Corporation intends to qualify as a Supporting Organization under Section 509(a)(3) of the Internal Revenue Code and Regulations issued thereunder, as now existing and as hereinafter amended. Notwithstanding anything provision to the contrary, these Articles of Organization and any By-Laws or other Operating Rules for the Corporation shall be construed and interpreted so as to allow continued eligibility for the Corporation to qualify as a "Type II Supporting Organization" that is specifically referred to in subparagraph (B)(ii) of Internal Revenue Code Section 509(a)(3).

2. Article Six of the Articles of Incorporation shall be deleted in its entirety and replaced with the following:

ARTICLE SIX - DIRECTORS

This Corporation shall have three (3) Directors initially. The number of Directors may be increased or diminished from time to time, by an amendment of the By-Laws when such amendment is adopted by the Directors, but shall never be less than three (3). The Directors shall be elected as stated in the By-Laws of the Corporation, provided that a majority of the Directors of the Corporation shall consist of individuals who also serve as Directors of the Jaeb Center for Health Research Foundation, Inc.
