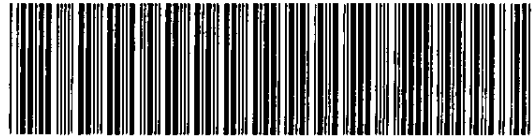

**AMENDED ARTICLES OF INCORPORATION
OF
JEWISH ENRICHMENT CENTER, INC**

The undersigned incorporator, for the purpose of forming a not for profit corporation in compliance with Chapter 617, F.S., hereby adopts the following Articles of Incorporation.

ARTICLE I. CORPORATE NAME.

The name of this corporation is **JEWISH ENRICHMENT CENTER, INC**

ARTICLE II. PRINCIPAL OFFICE.

ARTICLE III. PURPOSE.

The purpose for which the corporation is organized is a not for profit synagogue to perform religious services and religious education.

Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
